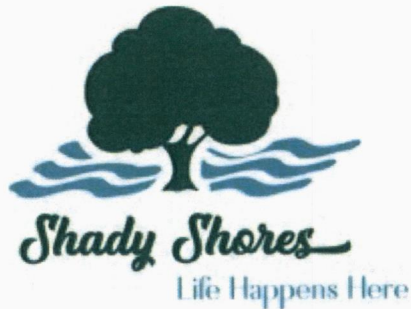

Community Relations- Communication Accessibility

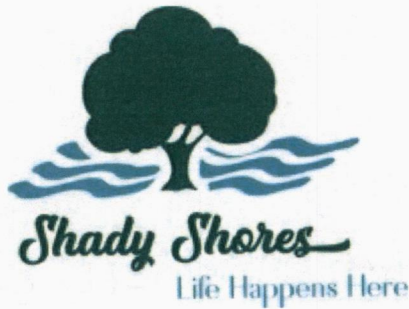
