Town Staff conducted a presentation and worksession regarding the building permit process.

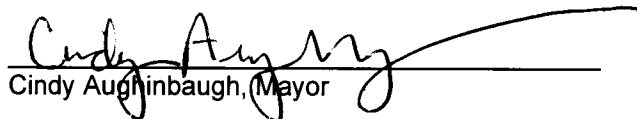

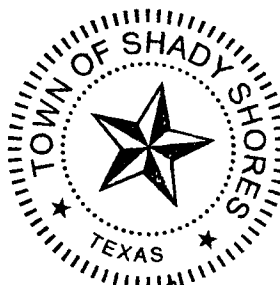

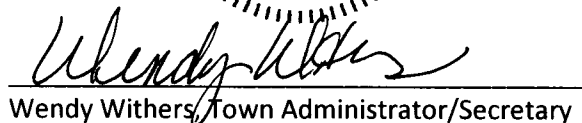
